### Federal Definition of Human Trafficking: Trafficking Victims Protection Act (TVPA)

# The recruitment, harboring, transportation, provision or obtaining of a person for...

### Sex Trafficking

...a commercial sex act, in which a commercial sex act is induced by force, fraud or coercion, or in which the person induced to perform such an act has not attained 18 years of age.

"Commercial Sex Act" means any sex act on account of which anything of value is given to or received by any person.

### **Labor Trafficking**

...labor or services, through the use of force, fraud or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

### Rights of Victims Under the TVPA



Victims should not be inappropriately incarcerated.



Not to be detained in facilities not appropriate for a victim.



Receive necessary medical care and other assistance.



To be provided protection if their safety is at risk.



Protection from intimidation and threats of violence.



Personal identifying information should remain confidential.



### Labor Trafficking

- The International Labor Organization estimates there are
   14.2 million people trapped in forced labor
- On average undocumented individuals pay between \$8,000
   and \$13,000 to come to the United States illegally America
- Vulnerable populations are frequently targeted by traffickers



# Indicators of Labor Trafficking

- Unpaid or very little pay
- Employed with no school authorized work permit and not on the "books"
- Falling asleep or increased absence at school
- Working outside permitted work hours
- Large debt and inability to pay it off
- Overly concerned with pleasing employer
- Not in control of their own money
- Living at place of employment
- Not being allowed to quit job
- Excessive work hours with little or no breaks



Domestic Minor Sex Trafficking (DMST) is the exchange of any sex act with a child under the age of 18, who is a US citizen or permanent resident, for anything of value.



# Child Sex Trafficking Legislation in CT

# **UNDER 18 years old** *CANNOT* **be ARRESTED for PROSTITUTION!**

- Victims can be classified as "uncared for" to receive services from DCF.
- Suspected cases shall be reported to the DCF Careline (800-842-2288).
- Child Sex Trafficking cases are to be reviewed & addressed through Multi-Disciplinary Teams (MDTs).
- Buyers paying to sexually abuse a child can be charged with Commercial Sexual Abuse of a Minor.
  - Class B felony when the child being purchased is age 15 to 17.
  - Class A felony when the child is under the age of 15.





# Multiple cases in every county in Connecticut. Average Total Referrals Per Year: 208 Age Range: 2-18 years old


### Years '16 thru '18



# Race and Ethnicity Averages between 2016 - 2018




### Residence at Time of Exploitation Average between 2016 - 2018

## LGBQ/GNCT Victims

**Under-Reported Problem** 

- Approximately 40% of homeless youth are LGBQ/GNCT
- Twice as likely to have run from home than straight youth

# RISK FACTORS & VULNERABILITIES From Exposure to Trauma

### Children with a history of traumas

- Physical Abuse/Neglect
- Emotional Abuse/Neglect
- Sexual Abuse
- Deprivation of Necessities
- Separation of Family/Community
- Rejection by Peers and/or Family
- Bullying
- Community Violence
- Involvement in Juvenile Justice

...are at higher risk and more vulnerable to victimization by child trafficking.



### THE TRAFFICKER

Anyone who benefits from the commercial sexual exploitation of a minor or facilitates the commercial sexual exploitation of a minor.

- Boyfriend or Girlfriend
- Father or Mother
- Brother or Sister
- Uncle or Aunt
- Peers or Friends
- It can be anyone that exerts control over a minor such as:

Police Officers, Clergy members, a Coach, or Teacher

- Any gender of varying ages
- Any ethnicity or race
- Not always organized crimes

### Routes of Human Trafficking in the U.S.

\*Crossing state lines is not required.



- Approximately 50 % of Exploiters work locally within the same community.
- Approximately 30 % of Exploiters work statewide.
- Approximately 20 % of Exploiters work across the country.

"High-frequency" Buyers

- Represent 75% of the market transactions
- 1<sup>st</sup> purchased sex by the time they turned 21 years old
- More likely to make \$100,000 or more annually
- 20.6% of men purchase sex at least once in their lifetime
- Only 6% of men report being arrested for buying sex





### Buyers on ONE given night...

# of Buyers per night ranges from 3-25

150,000 victims having sex with 10 buyers per night would mean that on any given night there are 1.5 million buyers exploiting children!

Victims are 7 times more likely to be convicted than their buyers...

Children in "the life" are often brutally raped on a daily basis, think of the impact that one rape has on the life of any person, imagine the impact of a thousand...



# Adolescence is a Risk Factor!

#### Why Do Victims Stay?

 Fear, distrust of health providers, government, police

 Unaware what is being done to them is a crime

 May develop loyalties, positive feelings toward trafficker as coping mechanism (trauma bonding)

 May not know where they are, because traffickers frequently move them to escape detection


 Fear for safety of family or oneself due to threat of violence

• Past experience of trauma






### Red Flags

- Frequent runaways, missing from care
- Hotel business cards, escort service business cards, hotel key cards
- Number of condoms, excess amounts of cash, or multiple cell phones
- Lack of identification and/or apparent age discrepancy
- Lack of Knowledge about whereabouts
- Knives or some kind of weapon
- Inadequately or inappropriately dressed for their present situation
- Scripted Communications or inconsistencies in stories and use of language of "The Life"





### More Red Flags

- Poor hygiene and/or malnourishment
- Bald patches or missing hair or fingernails
- Scars, mutilations, or infections due to improper medical care
- Vaginal and/or rectal trauma, urinary difficulties, pelvic pain, or pregnancy
- Unattended medical and/or dental issues
- Bruises in various stages of healing
- Reluctance to explain tattoos/ branding
- Over presence and controlling companion
- Unexplained gifts or items of value
- Fear, anxiety, depression, submissive, tense, and/or nervous
- Defensive, rude, evasive, and/or aggressive

#### **DAMAGE TO THE VICTIM**

Sexually transmitted infections, HIV/AIDS, pelvic pain, rectal trauma and urinary difficulties.

Unwanted pregnancy, resulting from rape or prostitution.

**Infertility** from chronic untreated sexually transmitted infections or botched and unsafe abortions.


Substance abuse problems and addictions.

Psychological trauma from daily mental abuse and torture.

Malnourishment and serious dental problem.

Undetected and untreated diseases, such as diabetes or cancer.

Bruises, scars and other signs of physical abuse and torture.

# Recovery, success and happiness is possible after victimization!

- Victim was exploited from the age of 14 to 18 years old
- She had previous traumas of domestic abuse and bullying
- The perpetrator was a family friend who used his position of power and trust
- He gave her gifts and money to "keep quiet"
- She escaped and received therapy

Today she is a successful, career driven woman who is committed to building awareness and combatting human trafficking...

#### Steps to Prevention

- ✓ Prosocial Activities and Supports
- ✓ Positive Connections with family, peers, teachers, coaches and mentors
- ✓ Mentoring and Coaching
- ✓ Internet and Social Media Safety
- ✓ Academic success and achievements
- ✓ Youth Employment Opportunities
- Educated community members regarding prevalence of sex trafficking and red flags
- Continued education for youth on sex trafficking and ways of being lured into the life
