In fiscal year 2020, CAC helped over 70 children and CAC volunteers made over 2,500 community contacts and advocated in court over 250 times. CAC volunteers donated over 3,500 hours of volunteer advocacy in the community and courtroom. Since CAC's founding in 2010, CAC has helped over 295 children and trained 155 volunteer advocates.
