Board members and key employees are required to disclose potential conflicts of interest annually and the board members conduct due diligence and determine by a majority vote of the disinterested board members whether the transaction or arrangement is in the Organization's best interest and shall determine whether to enter into or allow the transaction or arrangement. All discussions regarding conflicts of interest are documented in the minutes of the meetings.
